## **CONTEXT**

The recent <u>Granada declaration</u> issued by the leaders of the European Union puts a strategic emphasis on Europe's industrial future. With the goal of strengthening EU's position as an industrial, technological and commercial powerhouse, the future key actions of the Union are to create a special focus on areas of high added value where we already have a competitive edge or can become a frontrunner. Within the EU economy, industries are crucial for the prosperity of the member states, represent an accelerator and catalyst for change, innovation and growth. They do not only provide jobs, but also create and produce innovations, sustainable materials and services.

The EU has set out to increase the global competitiveness of its industries, as well as their autonomy and resilience. This is because the EU relies on industry to drive transitions towards climate neutrality and digital leadership. Consequently, the plans for EU's industrial transformation present several challenges, both for the EU and its member states. To ignite this change, tailor-made solutions and instruments need to be developed with the purpose of addressing the different industrial ecosystems of the European Union.

One of these challenges relates to the green transition. For Europeans, curbing climate change and environmental degradation is not only a legal and moral obligation, but it also represents a considerable opportunity. The main objectives of the green transition are to reduce the dependence on energy resources and critical raw materials, lower our electricity bills, make our companies more competitive, and create nearly one million jobs in this decade alone. In other words, the more the actions are implemented correctly timely, the more the generated prosperity contributes to increasing their quality of life.
