# A Challenging Semester

- During the Presidency, Romania will be handling the **very complex files** on the EU Agenda:
  - Brexit
  - Post-2020 Multiannual Financial Framework
  - Institutional Changes of the European Commission and the European Parliament
  - Unpredictable international environment.
- **Two key priorities** of the Romanian mandate:
  - Ensuring **the continuity of the EU agenda**
  - **Fostering good cooperation** between the member states and the EU institutions

Several processes are running in parallel in view of ensuring an efficient, timely and integrated preparation:

## 1. Preparing the logistics

- > 250 informal meetings in Romania to be organised
- > 1,500 experts to be selected and trained ·
- > 20,000 delegates to be hosted
- > 1,000 journalists will report from the field.

## 2. Setting the priorities

Political agenda as a forward-looking endeavour that puts the citizen at the heart of the process.

- Preparations should bring together the entire spectrum of political and institutional decision-makers, the civil society, mass media, academia and the society at large.
- **The *Forum of public consultations, communication and debate*** is a common discussion platform to ensure that every citizen has the possibility to get involved in the preparations.

- **The contest for selecting the logo for the Presidency**, jointly organised with the Ministry of National Education, was dedicated to high-school and university students
  - More than 200 projects submitted
  - More than 10,000 votes cast
- Winning proposal belongs to Ioan Nicolae Dobrinescu, a 15 years old student at the „I.L.Caragiale” National College in Bucharest and will represent the visual identity of our Presidency throughout the 6 months’ mandate.



- **The Future of the EU** – key topic on the agenda of the Romanian Presidency, which will take place during a crucial time for the future of the European Union.
- The EU will follow **an ambitious working agenda**, as reflection process shifts gears from debates to decisions
  - 19- 20 October European Council: agreement on Leaders' Agenda
  - The European Commission working plan for 2018
- Areas of **key focus**
  - Consolidation of the EMU
  - Reform of the Schengen area
  - Development of Social Pillar of the Union
  - Steps to improve the functioning and increase the efficiency of the EU

- Special European Summit in Sibiu on May 9<sup>th</sup> 2019
  - the EU leaders will take stock of proposals and will set out the framework for the 2019 – 2024 Strategic Agenda
- European Parliament elections in May 2019
  - with results determining the configuration of the European Commission

- Avoid fragmentation and division and focus on aspects that promote unity
- Promote real convergence, economic growth and opportunities for all
  - Ensure that the EU has efficient tools available to achieve this, such as the Cohesion and Common Agricultural Policy
- Promote the shaping of a post-2020 Multiannual Financial Framework with enough resources for policies that generate growth and convergence
  - Difficult topic, considering the pressure to reconsider priorities
  - Romania will make all efforts to ensure a balanced and timely agreement

- No other option but to **advance the integration process and consolidate the EU**
- Citizens need to be part of the decision-making process
- Romania intends to have a positive, constructive role in shaping the future of the EU
- Our objective is to strengthen the European project by effectively tackling the challenges of the current agenda.
- We support a stronger, more united, inclusive and competitive Europe of 27, based on its fundamental values and principles.
